- 4. Pond water treatment proposal Confirm with Allison and McCloud that at the bid includes all five retention ponds. The remaining votes for the bid to be accepted via email. During the meeting, unanimous vote by all four members at the meeting.
- 5. Lighting repairs bids Eola/Keating Greenview no longer part of bid process. Had trouble with other companies not interested and the bid as it is too small. We would like to get another bid instead of only one. With current company, ask them to inspect and bid on installing new lighting package at remaining four monuments and get a larger discount. Why, with the current findings, we suspect the other four were installed not to code and incorrectly as 87th & Eola. Vote to be conducted via email when bid is complete
