**SUPPLEMENT NO. 37 TO

This Supplemental Declaration is made and entered into by Aurora Land L.L.C., an Illinois limited liability company ("Declarant").

RECITALS

TICOR

Declarant recorded the Declaration for The Wheatlands (the "Declaration") on March 5, 1997 in DuPage County, Illinois as Document No. R97-031467, on March 3, 1997 in Will County, Illinois as Document No. R97017196, and on March 24, 1997 in Kendall County, Illinois as Document No. 9702654.

In Article Thirteen of the Declaration, Declarant reserved the right and power to add and submit certain real estate to the Declaration by making portions of the Development Area subject to the Declaration as part of the Premises. In Article Ten of the Declaration, Declarant reserved the right and power to record a Special Amendment to the Declaration to, among other things, correct errors or inconsistencies in the Declaration or any Exhibit thereto. Declarant exercised the rights and powers reserved in Article Ten and Article Thirteen by recording the following documents:

To reflect the addition of real estate to the Premises as set forth in Paragraph 2, to reflect the characterization of portions thereof for purposes of the Declaration, and to reflect the Assessment Points allocated to each Neighborhood, Exhibit B to the Declaration is hereby amended and restated to be as set forth in the Thirty-Seventh Amended and Restated Exhibit B to the Declaration for the Wheatlands which is attached hereto.

4. Covenants to Run with Land. The covenants, conditions, restrictions, and easements contained in the Declaration, as amended by this Supplemental Declaration, shall run with and bind the Premises, including the Added Premises.

5. Continuation. As expressly hereby amended, the Declaration shall continue in full force and effect in accordance with its terms.

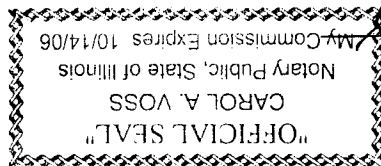
